

# Stamford Building Warranty Insurance

## New Build - Project Notification Form (PNF)

When applying for insurance, you must disclose any material facts to the insurer and the answers you give must be true and complete. A fact is material if it would influence the insurer in deciding whether or not to accept an application for insurance and if so, on what terms. You cannot disclose information which you do not know and you do not have to disclose information:

- which diminishes the risk being considered by the insurer
- which is of common knowledge
- which the insurer knows or ought to know in the ordinary course of business
- where your duty to disclose is waived by the insurer

**If you are in doubt about whether a fact is material or not, you should disclose it.**
